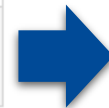



CHAPTER 1 General Provision

Article 1 (Purpose)

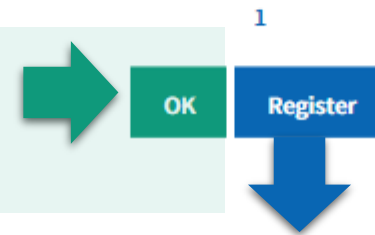
