Ombudsman's Message

The Foreign Investment Ombudsman system of Korea was established in 1999 with aims to provide aftercare support and grievance resolution service for foreign investors and foreign-invested companies in Korea.

Directly commissioned by the President of the Republic of Korea, the Foreign Investment Ombudsman works to resolve various grievances of foreign investors and foreign-invested companies through close cooperation with 'Home Doctors', who have deep knowledge and expertise in their respective fields of taxation, law, labor, environment, finance, immigration, etc. as well as with investment cooperation officers dispatched from the central and local governments.

Resolving grievances of foreign-invested companies not only enhances the business environment of Korea but also works to proactively respond to possible conflicts between Korea and foreign-invested companies; thereby making Korea as a more attractive investment destination.

Addressing difficulties of foreign-invested companies is much efficient approach to encourage reinvestment into Korea. A research by the World Bank indicated that costs by a host country government in attracting new FDI is five times larger than costs to expand reinvestment of foreign-invested companies doing business in the country.

The Foreign Investment Ombudsman system of Korea has been highly regarded by international organizations as a best practice for providing aftercare services to foreign investors to retain and expand their investment. As such, other countries, particularly developing economies, are benchmarking Korea's system.

Last year global foreign direct investment shrank significantly due to the pandemic. The COVID-19 shock on the economy is expected to be somewhat alleviated this year; however, the downward trend is likely to be remained even through Korea is in a favorable condition than other countries.

Curbing the spread of the pandemic came with each government's actions inevitably undermining cross-border business activities, and accordingly a range of difficulties emerged and foreign-invested companies in Korea were not exemptions. The Foreign Investment Ombudsman System and the Grievance Settlement Body

Purpose

- To resolve the grievances of foreign investors and foreign-invested companies effectively, and to contribute to improving the investment environment and attracting reinvestment.
- o Date of Establishment: October 26, 1999

Legal Basis

- Article 15-2 of the Foreign Investment Promotion Act (Foreign Investment Ombudsman, etc.)
 - Article 21-3 of the Enforcement Decree of the Foreign Investment Promotion Act (Functions, etc. of Foreign Investment Ombudsman)
 - Article 21-4 of the Enforcement Decree of the Foreign Investment Promotion Act (Operation, etc. of Grievance Committee)

Areas of Support

- All areas with regard to business & living environment, including investment system, investment incentives, taxation, finance, foreign exchange, labor, safety, fair trade, pharmaceuticals, tariff, customs, construction, environment, law, industrial site, visa, immigration, IT, intellectual property, etc.
 - * Exceptions include private disputes between companies, business of individual companies, requests that contradict global standards and matters that unjustly influence other companies or industries.

Responsibilities

- Assign Home Doctors (executive consultants) to each foreign-invested company to receive and resolve grievances
- Request cooperation to the government and relevant organizations, and recommend legislative improvements to resolve grievances
- Improve foreign investment system through external activities such as participating in the Foreign Investment Committee
- o Prevent grievances and conduct projects to improve investment environment
- Help reinvestment from foreign-invested companies

Introduction to the Foreign Investment Ombudsman System

- (Purpose) The Foreign Investment Ombudsman system was introduced on Octobr 26, 1999, under the Foreign Investment Promotion Act, for the purpose of supporting the affairs of grievance settlement in foreign- invested companies operating in Korea.
- (Appointment) The Foreign Investment Ombudsman is commissioned by the President on a recommendation of the Minister of Trade, Industry and Energy, via the deliberation of the Foreign Investment Committee.

| Legal Basis of the Foreign Investment Ombudsman System |

- Article 15-2 ①, ②, ⑩ of the Foreign Investment Promotion Act
- ① In order to resolve complaints from foreign investors and foreign- capital invested companies, foreign investment ombudsmen shall be commissioned from among persons with abundant knowledge and experience in foreign investment affairs.
- ② The foreign investment ombudsmen referred to in paragraph (1) (hereinafter referred to as "foreign investment ombudsmen") shall be commissioned by the President, after the recommendation of the Minister of Trade, Industry and Energy and deliberation thereon by the Foreign Investment Committee.
- ① A grievance committee shall be established within the Korea Trade- Investment Promotion Agency in order to support the duties of foreign investment ombudsmen.
- (Function) Foreign Investment Ombudsman and his grievance resolution body collect and analyze information concerning the problems foreign companies experience, request the cooperation of and recommend the implementation thereof to relevant administrative agencies, propose new policies to improve the foreign investment promotion system and carry out other necessary tasks to assist foreign-invested companies in solving their grievances.

| Legal Basis for the Function of the Office of Foreign Investment Ombudsman |

- Article 15-2 3 to 6 of the Foreign Investment Promotion Act
- ③ Where necessary for resolving complaints from foreign investors and foreign-capital invested companies, any foreign investment ombudsman may request the head of a relevant administrative agency and the head of a foreign-investment related agency (hereinafter referred to as "relevant administrative agency, etc.") to render the following necessary cooperation. In such cases, the head of a relevant administrative agency, etc. in receipt of such request shall comply therewith, except in extenuating circumstances:
 - 1. Giving explanations to a relevant administrative agency, etc. or submitting data in accordance with the standards prescribed by Presidential Decree;
 - 2. Stating opinions of related employees, interested persons, etc.;
 - 3. Requesting cooperation for site visits.

- Where deemed necessary after resolving complaints of foreign investors and foreign-capital invested companies, any foreign investment ombudsman may recommend the heads of relevant administrative agencies and the heads of public institutions to take corrective measures on related affairs.
- (§) Upon receipt of recommendations made under paragraph (4), the heads of relevant administrative agencies or public institutions shall, in writing, notify foreign investment ombudsmen of handling results within the period prescribed by Presidential Decree.
- 6 Where the heads of relevant administrative agencies or public institutions fail to implement recommendations made under paragraph (4), foreign investment ombudsmen may request them to submit matters concerning such recommendations to the Foreign Investment Committee as an agenda.

• Article 21-3 ② to ⑥ of the Enforcement Decree of the Foreign Investment Promotion Act

- 2 A foreign investment ombudsman shall perform the following duties:
 - 1. Investigation and handling of complaints of foreign investors and foreign-capital invested companies;
 - 2. Preparation of policy measures for improving a foreign investment system and recommendation on the implementation thereof to the relevant administrative agencies and public agencies;
 - 3. Other necessary matters for handling complaints of foreign investors and foreign-capital invested companies.
- ③ "Standards prescribed by Presidential Decree" in Article 15-2 (3) 1 of the Act means any of the following:
 - 1. Where it is necessary for investigating whether a foreign investment-related system complies with international practices or standards;
 - 2. Where it is necessary for tackling difficulties experienced by foreign-capital invested companies in their management or improving the related systems;
 - 3. Where it is necessary for improving the living conditions of foreign investors and foreigners working for foreign-capital invested companies.
- 4 A recommendation for corrective measures under Article 15-2 (4) of the Act (hereafter referred to as "recommendation for corrective measures" in this Article) shall be made in a document specifying the following matters:
 - 1. Current status and problems of related statutes, institutions and policies;
 - 2. Details of recommendation for corrective measures;
 - 3. Matters recognized by foreign investment ombudsmen as being necessary, such as the reply deadline for related administrative agencies and public agencies.
- (§) "Period prescribed by Presidential Decree" in Article 15-2 (5) of the Act means 30 days after receipt of a recommendation to take corrective measures from a foreign investment ombudsman pursuant to Article 15-2 (4) of the Act.
- ⑥ A foreign investment ombudsman may verify and inspect the performance of the details of recommendations for corrective measures.

(1) Establishment and legal basis

- Placed as a dedicated office within the KOTRA's headquarters
- o Legal basis: Article 15-2 10 of the Foreign Investment Promotion Act

2. Responsibility

(1) Duties and jurisdiction

- As stated in Article 21-3 ② of the Enforcement Decree of the Foreign Investment
 Promotion Act, a foreign investment ombudsman identifies and resolves difficulties of
 foreign-invested companies, provides measures to improve the current system, and makes
 recommendations to the government of Korea.
 - * The grievance settlement body is to support the duties of foreign investment ombudsmen; therefore, the body's duties are deemed to be identical with foreign investment ombudsmen.

Article 21-3 of the Enforcement Decree of the Foreign Investment Promotion Act (Functions of Foreign Investment Ombudsmen, etc.)

- ② A foreign investment ombudsman shall perform the following duties;
 - 1. Investigation and handling of complaints of foreign investors and foreign-capital invested companies;
 - 2. Preparation of policy measures for improving a foreign investment system and recommendation on the implementation thereof to the relevant administrative agencies and public agencies;
 - 3. Other necessary matters for handling complaints of foreign investors and foreign-capital invested companies.
- To perform the above duties, according to Article 15-2 ③, ④, ⑥ of the Foreign Investment Promotion Act, a foreign investment ombudsman requests the cooperation of relevant administrative agencies, make recommendations and raise other necessary tasks to the Foreign Investment Committee to improve the foreign investment promotion system.

(2) Work descriptions

 In accordance with the Enforcement Decree of the Foreign Investment Promotion Act, KOTRA specified the tasks of the grievance settlement committee into its own operational policy

3. Operation of the Grievance Committee

(1) Head of the grievance committee

In accordance with Article 21-4 ② of the Enforcement Decree of the Foreign Investment
 Promotion Act, a Foreign Investment Ombudsman lead a grievance committee.

| Article 21-4 2) of the Enforcement Decree of the Foreign Investment Promotion Act |

- ② A Foreign Investment Ombudsman shall be the head of a grievance committee under Article 15-2 ⑩ of the Act (hereinafter referred to as "grievance committee").
- (Note) At first the Head of Invest KOREA was in charge of the grievance committee, when
 it was located within the Korea Investment Service Center(KISC). However, the Foreign
 Investment Ombudsman has been the head of the committee as it became independent
 in May 2006.

(2) Decision making

 According to the Article 21-4 ® of the Enforcement Decree of the Foreign Investment Promotion Act, the president of KOTRA has rights to decide any issues regarding the grievance settlement body(grievance committee).

| Article 21-4 (8) of the Enforcement Decree of the Foreign Investment Promotion Act |

® Except as otherwise expressly provided for in paragraphs (2), (3), (5), (6) and (7), matters necessary for the organization and operation of the grievance committee shall be determined by the president of the Korea Trade-Investment Promotion Agency following deliberation by the Foreign Investment Committee.

II. Foreign Investment Aftercare Performance 2020

1. Grievance Resolution Activities and Achievements

(1) Overview

- Home doctors assigned to each company are using a range of means such as roundtable meeting, on-site visit, communication via phone and email, and etc. to identify problems faced by foreign-invested companies.
- The Office of the Foreign Investment Ombudsman in 2020 resolved 357 grievances in total,
 7.5 percent increase from 332 grievances of 2019.
- The grievances handled by the Office of the Foreign Investment Ombudsman are categorized into three types; legislative improvement, administrative intervention, and Home Doctor resolution.

Legislative Improvement regulatory reforms and/or making changes in law by cooperating with relevant agencies and local governments to resolve grievances of a foreign-invested company Administrative Intervention resolving grievances by providing appropriate procedural interpretation or support from an existing legal framework

Home Doctor Resolution grievances solved by Home Doctors's consultation, support, and etc.

 By grievance resolution type, 17 grievances were addressed through legislative improvement, 240 grievances by administrative intervention, and 100 grievances by Home Doctor resolution, which were increased 6.3 percent, 3 percent, and 29.8 percent respectively from the previous year.

Overall, grievances by area were more frequent in the order of standard, certification & inspection (61 cases), environment (60 cases), visa & immigration (37 cases), taxation (36 cases), insurance & welfare (21 cases), labor relations & HR (21 cases), customs & trade (18 cases), finance & foreign exchange (15 cases), and intellectual property (14 cases). The numbers showed a higher need for supports in specialized and professional areas.

1. Mitigate the re-	entry permit system for long-term stayers(legislative improvement – urgent)
Grievance	 MOJ announced the introduction of a quarantine measure to enforce re-entry permit system and submission of diagnosis for re-entry of long-term stayers (May 23). Requirements and application process of the permit was not clearly indicated, and it was practically impossible to prepare a diagnosis written (in English) by a doctor and notarized within 48 hours from departure for Korea.
Support	 OFIO immediately called a video meeting (May 26) with the foreign chambers of Korea, including the US, EU, Germany, the UK, France, Japan, China, and India, to listen to the opinions on the ground such as expected difficulties. OFIO compiled and studied possible damages, influences, and similar measures from other countries. The Ombudsman convinced high ranking officials about the significance and urgency of the matter, and discussed to amend the policy by considering the results from the video meeting and research.
Result	 MOJ incorporated the opinions within the policy and released a revised version (Jun. 1) as follows; Establish e-application system for re-entry permit for user's convenience, earlier than the original plan Provide an exemption for submitting a diagnosis; departure for the business, journalism and academic activities and re-entering Korea within three weeks For unavoidable cases, a diagnosis issued with in three days shall be accepted Under exceptional circumstances, a diagnosis written in a third language other than English or Korean can be accepted
2. Required docume investment	ents for foreign-invested companies (LLC) to report unappropriated retained earings as foreign
Grievance	 A foreign-invested company (LLC) intended to establish core R&D facilities by using their unappropriated retained earnings and attempted to report this as a new foreign investment. However, financial statements of LLC, which is not subject to external audits, were not accepted as valid documents in the process; thereby causing problems in the company's plan.
Support	 A home doctor from OFIO thoroughly reviewed the company's financial statements and the mother company's consolidated financial sheets to confirm the accuracy and credibility of the data. OFIO conducted research about accounting for unappropriated retained earnings (Commercial Act), accounting standards, and compliance with the company's articles of association. With research outcomes, OFIO consulted with MOTIE whether to recognize the company's documents as valid.

2. Required docum investment	nents for foreign-invested companies (LLC) to report unappropriated retained earings as foreign
Result	 As a result, the documents from the aforementioned company are duly accepted by acknowledging that their proving documents are legitimately prepared by a credible agent in accordance with accounting standards → The company's reinvestment using their unappropriated retained earnings are approved and reported as foreign investment. It is expected that, when another LLC is reporting foreign investment using their unappropriated retained earnings in the future, this case can be a supporting precedent in accepting financial statements of LLC as a valid evidence.
3. Change the price	cing guideline for industrial gas to be more responsive to global trends
Grievance	 While global prices of materials are fluctuating due to the pandemic and unstable oil prices from Russia and the Middle East, domestic gas prices were not immediately reflecting the global trends. According to the related guideline, domestic gas price was renewing every two month to reflect changes in material prices. Company A was supplying industrial gas in line with international prices, but, due to the time difference in domestic gas pricing system, they had to put up with sales loss continuously.
Support	 OFIO looked into the details in the pricing process of the domestic gas fee and how Korea is reflecting international oil price into the system. Also, OFIO consulted with Company A and to take a closer look at the sales loss and its trigger. After compiling the information, the meeting between MOTIE and Company A was arranged to discuss complementary measures to minimize losses in companies like A when unexpected changes in the world are occurring.
Result	MOTIE acknowledged the Company A's claim and therefore amended the guideline to shorten the updating cycle from two months to each month. Yet, the gas price for household, to stabilize gas prices, is decided to retain the existing pricing system.
4. Korea-China Fa	st Track Entry Procedure to Incorporate D-7 Visa
Grievance	 The 'fast track entry procedure', which is exempting business travelers from self-isolation requirements, between Korea and China were only allowed for D-8 and D-9 holders. Yet, many Chinese investors hold D-7 visa in Korea, especially in finance and aviation industry, so they were excluded from the benefit of the fast track process.
Support	 OFIO reached out to MOTIE to review the situation of the fast track process and discussed measures to expand the scope of eligibility. OFIO contacted with MOFA to exchange opinions in amending the existing conditions for the fast track process. Through a meeting with Korea Immigration Service, the Ombudsman reiterated the need to broaden the scope of who can apply for the fast track procedure, by explaining difficulties and grievances of business communities.
Result	The OFIO's recommendation was acknowledged and the government announced a new guideline that D-7 visa holders can apply for the fast track process.
5. Allow European	investors to apply for Korea-Singapore fast lane system
Grievance	 There was the need to enhance the convenience of EU investors going in/out of Korea, with an aim to minimize any damages from contracted business activities due to the pandemic. The European business community raised their opinions to fairly treat themselves as Korean nationals in quarantine regulations.

5. Allow European	investors to apply for Korea-Singapore fast lane system
Support	 OFIO checked and reviewed various information such as the current status of Korea-EU visa exemption, the list of EU countries allowing Korean to enter their countries, the trend of using the re-entry permit, and the recent number of the COVID-19 confirmed patients in major EU countries. Given the outcomes from the OFIO's analysis, OFIO communicated with MOJ along with the ECCK's written statement.
Result	 MOJ decided to include 'long term visa holders' in who can apply for Korea-Singapore fast lane for essential travel A businessperson with a negative coronavirus test and a travel pass from Singapore can be exempted from isolation duty. Long-term visa holders who have stayed in both countries for more than 14 days are also eligible for the fast lane.

(3) Administrative intervention

- The term 'administrative intervention' indicates resolving a grievance by providing proper interpretations or other necessary supports within existing legal frameworks, in cooperation with responsible government authorities.
- For last year, 240 grievances required administrative intervention, and, among them, 55 cases were in environment area, 54 cases in standards, certification & inspection, 28 cases in taxation, 14 cases in customs & trade, and 12 cases in insurance & welfare.
- The whole list of grievances addressed by administrative intervention during 2020 is attached as Annex 1.
- o Examples for administrative intervention in 2020

1. Encourage amica	able agreement between foreign-invested company and traditional market
Grievance	 Company A made a plan to open a new store near traditional markets and prepared necessary arrangements. Yet, small business owners from near traditional markets opposed the opening due to concerns over possible losses in their businesses. Concerns became lots of claims opposing A's new store, so the responsible local government does not approve the Company A's construction. All negotiations that Company A had with the representatives of the traditional markets broke down, and then the issue was transferred to arbitration by the responsible ministry.
Support	 OFIO had two times of consultation with Company A's executives to look through the history of the issue, what is the key matter, and what kinds of support OFIO can provide. OFIO made a Home-doctor unit to carry out in-depth study about locations of the traditional markets and the A's new store and possible influences on commercial activities. Additionally, OFIO scrutinized administrative procedures and applicable laws. OFIO, with research outcomes, asked for cooperation from the related ministry to encourage harmonious co-existence between Company A and the traditional markets.
Result	 After the ministry arbitrated two sides, eventually an agreement was settled, and the company was approved to commence its construction. Two sides reached an agreement and Company A arranged measures to create a win-win situation. The traditional markets withdrew their claims and agreed with A's arrangement.

2. Advocating a for circumstances	reign-invested company to keep their construction approval, in consideration of unavoidable
Grievance	 At first, Company B received a permit from the responsible local government for a business plan containing a performance show using wild animals. Yet, Company B had to carefully eye recent moves to amend relevant laws (e.g. Wildlife Protection and Management Act, Act on the Management of Zoos and Aquariums, etc.) and naturally the implementation of the business plan was delayed, resulting in a failure to start construction within the due date stated in the permit. Against the backdrop, the responsible local government notified Company B that a hearing will be held before cancelling the B's approval due to their failure of implementation. Then the company came to OFIO looking for help in maintaining the approval.
Support	 OFIO examined documents that the Company B submitted and double-checked relevant articles from the Administrative Procedures Act and Tourism Promotion Act. OFIO made a unit to have them immediately visit the site and arrange meetings with concerned parties. The local government explained in the meeting that, although a hearing is unavoidable according to the administration process, they were positively reconsidering the issue, and informed what is needed for due process of law. OFIO agreed and encouraged the local government to positively re-examine the issue, particularly considering the fact that C's construction site is within a individual foreign-investment zone OFIO shared with Company B that the hearing must be conducted for fair process and that there are some points in question that Company B needs to defend themselves.
Result	 After the hearing by the local government, the cancellation of the approval was put on hold by recognizing the delay as a result of force majeure and B's willingness to swiftly make follow up measures.
3. Grievance regar	rding a permit to establish a direction measuring instrument of wind
Grievance	 Company C hoped to establish a direction measuring instrument of wind in the project site in order to test the profitability of a project to create an onshore wind farm. On the other hand, Company C was failed to have an approval from the responsible authority due to concerns over that establishing the wind measuring instrument would like to reduce the production of forest products, to lower local resident's income, to generate risks in hiking trail, and to disturb the scenary.
Support	 OFIO contacted the authority and checked any developments since the company's application, including the authority's perspectives and possibilities for reconsidering the application. After that, OFIO recommended Company C to clearly state local residents' agreement in C's business plan, and to re-apply for the approval after seeking advice from those who have been approved. Company C revised their business plan and reapplied for the approval. In addition, the company visited the authority, as they were advised from others, to explain their business.
Result	The permit was eventually approved, and the company was able to kick off their business as it was planned
4. Foreign-invested	d company's reinvestment and following incentives for corporate tax
Grievance	 Company D needed reinvestment to expand its facilities converting raw materials. Yet, it was expected that the reinvestment would decrease the current benefit for corporate tax, so the company asked whether there are other incentives to offset the expected loss.
Support	 OFIO's home doctor examined articles of the Restriction of Special Taxation Act, with regard to D's investment plan and concerns It was confirmed that, according to the Act, where the foreign-invested company alters the details of the business subject to a decision on tax benefit, and intends to obtain a tax cut for the altered business, it shall file an application for altering the details of tax reductions/exemptions within two years from the date that the relevant alteration arises. MOEF also clarified that altering the details for capital increase of the business not separating the account is recognized as a share capital of the investor.

Result	 The home doctor had a meeting win Company D to share his/her examination and MOEI response, and recommended to carry out reinvestment without worries over tax relief.
5. Using employme	nt contract to apply for foreigner registration card
Grievance	 Company E dispatched a professional technician in repairing high-end watches from Hon Kong to Korea, and this was because there was no such technician Company E can hir within Korea. As the technician entered Korea being contracted with Hong Kong office, he/she could no submit his/her contract with the headquarters – a mandatory requirement to apply for foreigner registration card.
Support	 OFIO contacted MOJ to confirm that the D-8 visa guideline was partially amended and the a document to prove one's dispatch between overseas offices is acceptable. In addition, it was verified that an employment contract with Korea office is a valid alternative demonstrating one's income within Korea.
Result	The employee submitted an employment contract with Korean office, and consequently foreigner registration card for skilled-workers was issued.
6. Earlier visa issu	ance of an executive with regard to reinforcing the company's R&D function
Grievance	 Due to the pandemic, Company F urgently changed a vice president's new post to Korea and the appointment was to strengthen R&D functions in the Korean office. The executive requested earlier issuance of visa, considering his/her family to better settle down in Korea without difficulties.
Support	 OFIO reached out to KOTRA New York Office, as the executive was staying in New York to have their assistances in convincing the Korean embassy to New York. OFIO and KOTR NY Office explained his/her vital role in building up R&D capacity, and requested earlie issuance of the visa.
Result	 The embassy accepted the request's rationals and its necessity, so promptly issued the vis after an interview.
7. Isolation exempt	ion for project manager to establish R&D center R&D
Grievance	 Company G was pushing forward with their plan to establish a R&D center in Korea. For important decision making about project management, Company G's headquarters wished to send a project manager to Korea for one month. However, it seemed infeasible to follow the schedule due to 14 days of isolation duty for inbound travelers.
Support	 OFIO and MOTIE screened the necessity of the manager's isolation exemption by takin consideration of the project's purpose and its importance. After that, MOTIE sent an official request in written to MOFA to exempt the manager from the isolation duty.
Result	 MOFA approved the exemption and the manager was able to enter Korea and start th work as planned.
8. C-3 visa for pro	ject engineer of a new investment project
Grievance	 An engineer from Company H applied for C-3 visa to enter Korea from a third country. The visit was to jointly implement a new project with a Korean company. Due to the pandemic, in order to apply for a visa, it was necessary to meet the qualifications for exemption from self isolation. For this, company H had to prove the reason for the visa application but they could not submit the information as the project confidentiality.

8. C-3 visa for project engineer of a new investment project				
Support	 OFIO, in cooperation with MOJ, scrutinized and confirmed that the engineer met the requirements for C-3 visa. MOTIE sent an official request to MOFA and the embassy to proceed with the visa issuance process after they review and confirm that there is no other safety problems. 			
Result	MOFA finished their review and cooperated to arrange the visa interview for the engineer, without the status for isolation exemption.			
9. Isolation exemption for an executive to make reinvestment decisions				
Grievance	 Company I planned to invite its president from abroad to Korea to make decisions about reinvestment and expanding investment shares. The government considered that this rationale was insufficient for having quartation exemption and a short-term visa under the COVID-19 situation. 			
Support	 OFIO reviewed the documents from the Company I, and recommended to highlight the importance of the president's visit to Korea for significant investment decisions. After reviewing the documents from Company I, OFIO recommended them to emphasize the importance of the president's in-person visit to Korea and his significant role in making investment decisions. 			
Result	 MOTIE recognized that the visit is necessary and provided its recommendation to the related ministry for isolation exemption. Subsequently, it has become possible for the president to apply for short-term visa. 			

(4) Home doctor resolution

- To address grievances, home doctors in the Office of the Foreign Investment Ombudsman use their expertise and knowledge not only to offer consultations to correctly understand Korea's regulatory environment but also to provide necessary guidelines for foreign investors.
- 100 grievances raised and resolved in 2020 are categorized into home doctor resolution.
 It is notable that specific issues requiring professional knowledge account for majority of the 100 cases; for example, visa & immigration (26 cases), investment incentives (12cases), labor & HR (11 cases), finance & foreign exchange (9 cases).

(5) Timely support for COVID-19

- The Office of the Foreign Investment Ombudsman closely engaged with foreign companies
 and foreign chambers of commerce in Korea to promptly respond to COVID-19, with aims
 to minimize any damages generating from the pandemic and quarantine policies stricter
 immigration procedures, different living environment, and contracted business activities.
 By doing so, the Office was able to share necessary information to companies and related
 updates from the government in a timely manner.
- 78 grievances related to the pandemic was closed last year. Among them, immigration related issues (32 cases) dominated the grievances, and it was followed by labor related consultation and support (9 cases) such as employment retention subsidy, and etc.

2. Sharing Legislative Information

(1) Overview

- Regulatory Information Service for foreign investors are provided by the Office of the Foreign Investment Ombudsman to seek opinions of foreign-invested companies and reflect them in the legislative process. To this end, the government and national assembly's legislative proposals relevant to foreign investment are translated into English, and published in the Office's website and newsletter.
- In 2020, a total of 570 legislative proposals (299 from the government and 271 from the national assembly) were translated and made available by the Office of the Foreign Investment Ombudsman as a result of its effort to strengthen monitoring of the regulatory environment and to analyze correlation between legislative proposals and grievance areas. Compared to the previous year of 242 proposals, the performance in 2020 rose 135.5 percent.


(3) Monitoring of legislative proposals

- The Office of the Foreign Investment Ombudsman sorted out the top five areas of the most frequently reported source of grievances, from last year's data, and studied correlation between foreign investment and legislative proposals in such areas. This was to provide more English-translated information for foreign investors and foreign-invested companies.
- To this end, how many legislative proposals were translated in 2020 was utilized as an indicator to recognize the number of new regulations introduced in the top five areas.



 In 2020, 79 legislative proposals by the government were additionally translated compared from the previous year. Other than insurance & welfare area, other four areas showed significant increase in the number of translations.

 On the other hand, translation service for the national assembly's legislative proposals was mainly for labor & HR, insurance & welfare areas. It is therefore analyzed that regulatory and legislative discussions were intense in such areas and accordingly the translation for the areas also was increased.



3. Reinvestment Attraction Performance

(1) Overview

- The Office of the Foreign Investment addressed grievances that are directly and indirectly
 affecting reinvestment decisions of foreign-invested companies doing business in Korea
 such as new or additional establishment of production facilities, staffing, and expanding
 the business.
- In 2020, among all foreign-invested companies that the Office of the Foreign Investment Ombudsman supported, 24 companies reported \$486 million of reinvestment. The reinvestment amount accounted for 6.3 percent of the whole reinvestment (\$77.5 billion) reported to Korea, meaning that the Office of the Foreign Investment Ombudsman is indeed working to contribute to attracting more investment into Korea.

1. Roundtable Meetings

(1) Introduction

- The Office of the Foreign Investment Ombudsman provides venues to channel foreigninvested companies' voice to relevant authorities. By doing so, the Office recognizes current issues and possible grievances in a timely manner and seeks solutions with relevant authorities.
- By meeting's purpose and characteristics, it can be categorized into several types such as policy roundtable meeting with high-ranking officials, small group meeting, working-level discussion, etc.

 In 2020, webinars were an important tool to continuously facilitate communication between foreign-invested companies and government organizations amid the unexpected challenge posed by COVID-19 and social distancing rules.

2. International Cooperation and Promotion Activities

(1) WTO's workshop on Concrete Measures to Facilitate the Flow of Sustainable FDI (Mar. 11, 2020)

- The Foreign Investment Ombudsman was invited to give a presentation at the WTO's workshop on Concrete Measures to Facilitate the Flow of Sustainable FDI, Session III (The Institution of the Ombudsman) to share Korea's experience and to provide opinions.
 ** Due to COVID-19, the offline workshop was switched to an webinar
- Via the webinar, the unique feature of Korea's foreign investment ombudsman system and aftercare services were introduced to the OECD, Brazil, Nigeria and Bangladesh, and other developing counties as well as international aid agencies.
- The ombudsman system of Korea was referred to as a benchmarking model for countries looking for economic growth through foreign investment, and accordingly it is deliberated how to transfer the model to share Korea's experiences with the international community.

- In accordance with Article 21-4 ⑦ of the Enforcement Decree of the Foreign Investment
 Promotion Act, the Office of the Foreign Investment Ombudsman publishes the 'Report on
 Grievance Resolution for Foreign-Invested Companies' every quarter by compiling cases of
 grievances resolved by the Foreign Investment Ombudsman and local governments.

| Article 21-4 of the Enforcement Decree of the Foreign Investment Promotion Act (Operation, etc. of Grievance Committee) |

- The head of the grievance committee shall analyze the results of setting complaints raised by foreign-capital invested companies on a quarterly basis and report them to the Minister of Trade, Industry and Energy within one month after expiration of each quarter.
- The 'Report on Grievance Resolution for Foreign-Invested Companies' is composed of grievance resolution, reinvestment attraction, and grievance preventive activities of the Grievance Committee every quarter as well as local government aftercare services for foreign companies. In addition, to promote the Foreign Investment Ombudsman System, the report introduces meetings with foreign delegations, roundtables for foreign-invested companies, and media activities.
- By distributing the quarterly report to 17 local governments and major institutions, the
 Office of the Foreign Investment Ombudsman shared the grievance resolution cases of
 Grievance Committee and local governments, promoted the work of the Foreign
 Investment Ombudsman, and helped establish an effective aftercare system.

Annex 3. Trends of FDI in 2020

For your reference, the Annex 3 provides the information and analysis summarized from UNCTAD's World Investment Report 2020 as well as 2020 Foreign Direct Investment Trends by the Ministry of Trade, Industry and Energy, Korea.

1. Global Foreign Direct Investment in 2020

(1) Global FDI's volume and trends

Overview) In 2019, global FDI flows increased by 3 percent, to \$1.54 trillion. Inward FDI flows to developed economies rose by 5 percent, to \$800 billion. It was concentrated in Europe, but mainly because of jumps in a few economies, such as Ireland and Switzerland, after sharply negative inflows in 2018. However, FDI to some of the larger economies in the region declined. FDI in the US, the largest recipient economy, declined by 3 percent to \$246 billion.


(2) Regional FDI's volume and Trends

- (Developed economies) FDI flows to developed economies rose 5 percent, to \$800 billion.
 The increase occurred despite weaker macroeconomic performance and policy uncertainty for investors, including trade tensions and Brexit. The trend was mainly driven by FDI dynamics in Europe, where inflows increased by 18 percent to \$429 billion.
- (Developing economies) FDI flows to developing economies declined marginally, by 2 percent, to \$685 billion. Since 2010, flows to developing economies have been relatively stable, hovering within a much narrower range than those to developed countries, at an average of \$675 billion.
 - In 2019, FDI flows to Africa already declined by 10 percent to \$45 billion. Tepid global and regional GDP growth and dampened demand for commodities inhibited flows to countries with diversified and natural resource-oriented investment profiles alike, although a few received higher inflows from large new projects.
 - FDI flows into developing Asia in 2019 declined by 5 percent, to \$474 billion. The decline was driven primarily due to a fall in investment in Hong Kong, China and Korea.
 - In 2019, FDI in Latin America and the Caribbean grew by 10 percent to \$164 billion, driven by increased flows to Brazil, Chile and Colombia. Outflows grew to \$42billion, sustained by intra-regional flows and a reduction of negative outflows that dampened the


totals in previous years.

- FDI inflows to structurally weak, vulnerable and small economies represented less than 3 percent from the global FDI inflows. In 2018 FDI flows to the least developing countries reported \$24 billion, showing a recovery sign from last year's decline.


(3) Trend analysis and outlook for global FDI

- The COVID-19 crisis will cause a dramatic fall in FDI. Global FDI flows are forecast to decrease by up to 40 percent in 2020, from their 2019 value of \$1.54 trillion. This would bring FDI below \$1 trillion for the first time in 2005. FDI is projected to decrease by a further 5-10 percent in 2021 and to initiate a recovery in 2022. A rebound, with FDI reverting to the pre-COVID underlying trend in 2022, is possible, but only at the upper bound of expectations.
- The downturn caused by COVID-19 follows several years of negative or stagnant growth; as such it compounds a longer-term declining trend. The expected level of global FDI flows in 2021 would represent a 60 percent decline since 2015, from \$2 trillion to less than \$900 billion.

(Unit: Trillions of dollars)



- The pandemic is a supply, demand, and policy shock for FDI. The lockdown measures are slowing down existing investment projects. The prospect of a deep global recession will lead multinational enterprises(MNEs) to re-assess new projects. Policy measures taken during the crisis include new investment restrictions. Longer term, investment flows will slowly recover staring in 2022, led by GVC restructuring for resilience, replenishment of capital stock and recovery of the global economy.
- Over the years of 2020 and 2021, the demand shock will be the biggest factor pushing down FDI. Although in general the trend in FDI reacts to changes in GDP growth with a delay, the exceptional combination of the lockdown measures and the demand shock will cause a much faster feedback loop on investment decisions. The demand contraction will hit FDI in the first half of 2020 and then fully unfold in the second half of 2021.
- Both new greenfield investment project announcements and cross-border M&As dropped by more than 50 percent in the first months of 2020. Both new greenfield investment project announcements and cross-border M&As dropped by more than 50 percent in the first months of 2020. The top 5,000 MNEs worldwide, which account for most of global GDP, have seen expected earnings for the year revised down by 40 percent on average, with some industries plunging into losses.
- In 2019, the internationalization rates of the top 100 MNEs remained flat. The average Transnationality Index (TNI) of the top 100 the relative shares of their foreign assets, sales and employees has plateaued in the last decade at about 65 percent. This is caused in part by changes in the composition of the list, with new-emerging-market entrants starting out at lower levels of internalization.


(4) Investment policy developments

- (Coexistence of protecting domestic industries and investment facilitation policies) Investment policy are part of the response to COVID-19. More than 70 countries have taken measures to mitigate the negative effect on FDI or, conversely, to shield domestic industries from foreign takeovers. Several countries have taken steps to alleviate the administrative burden for firms and to reduce bureaucratic obstacles with the aim of speeding up production or delivery of goods during the pandemic. The crisis and the resulting disruption of regular government services have also accelerated the uptake of online tools and e-government platforms providing continuity of essential services for business and investors.
- (Screening of foreign investment) In 2019, 54 countries and economies introduced at least 107 policy measures affecting foreign investment, with developing economies in Asia the most active, accounting for almost 50 percent. The total number of new policy measures continued to decrease for the second consecutive year since the peak in 2017. 76 percent of newly introduced measures aimed at liberalizing, promoting and facilitating investment, while the remaining 24 percent related to new restrictions or regulations.




• (The IIA Landscape and Changes) In 2019, 22 new international investment agreements(IIAs) were signed, and the number of IIA terminations continued to increase. In 2019, at least 34 treaties were effectively terminated, of which 22 unilaterally, six by consent, four by replacement and two by expiry. For the second time since 2017, the number of IIA terminations exceeded the number of new treaty conclusions.

• (Investor-state dispute settlement) Investors in 2019 initiated 55 publicly known ISDS cases pursuant to IIAs, the lowest number in five years. As of Jan. 1, 2020, the total number of publicly know ISDS claims had reached 1,023. As some arbitrations are kept confidential, the actual number of disputes filed in 2019 and previous years is higher. More than half of the arbitral decisions rendered on jurisdictional grounds in 2019 were in favour of the State. Those on the merits more frequently ended in favour of the investor.

2. Foreign Direct Investment Trends in Korea

(1) Overall

(Results) Foreign direct investments pledged to Korea in 2020 recorded USD 20.7 billion, reaching \$20 billion for six consecutive years since 2015. (The FDI that actually arrived in Korea decreased 17.0 percent to \$11.1 billion.). On the other hand, the figure was 22.9% down from the record high in 2018.

- The 2020 performance is slightly below the recent five-year average of \$23 billion.
 However, investment inflows to Korea remained relatively resilient to the impacts of COVID-19 that wrecked havoc on the global FDI trend.
 - * UNCTAD projected the global FDI to plunge 30~40% in 2020, and as it was expected the global FDI in the first half of 2020 went down 49% to \$399 billion compared to the previous year.
- In spite of the pandemic, the aforementioned FDI flows to Korea in 2020 proved that Korea is one of the safest investment destination in the world.

- With the outbreak of the virus, the FDI decreased significantly in the first half of the year, but the decline was greatly mitigated with Korea's quarantine efforts, virtual IR meetings, and strategies to attract promising investors.
 - * (notification basis, YoY): the first half (\$7.6 billion, \triangle 22.4%) \rightarrow the second half (\$13 billion, \triangle 2.8%)
 - New industries related to the 4th industrial revolution technologies such as artificial intelligence, big data, cloud computing, eco-friendly vehicles, and bio-health products saw noticeable improvements in FDI attraction (notification basis). Moreover, FDI in not

- only manufacturing (e.g. secondary batteries, pharmaceuticals) but also service (e.g. e-commerce, R&D) areas went up from the previous year.
- High-tech materials, parts and equipment sectors including semiconductors, secondary batteries and eco-friendly auto parts attracted continued interests in R&D investments. In particular, investments to develop and manufacture electric vehicle parts and to diversify supply chains of chips and display materials, parts and equipment in response of Japan's export restrictions were active. While the amount of FDI in the manufacturing sector greatly dropped in the first half of the year, the amount rebounded and surged in the second half.
- Investment in Korea's Green New Deal projects also went up and FDI pledges to accelerate low-carbon energy transition were noteworthy. Investments in wind and solar renewable energies and green technologies including water treatment and waste management more than doubled in 2020.

(2) Outlook

- FDI to Korea in 2021 is forecast to be affected by positive and negative factors remaining in global and domestic market, posing challenges for Korea to tide over.
- UNCTAD projected a 5-10 percent FDI slide in 2021 but also expected an economic recovery in 2022. However, investors are likely to remain cautious in committing capital to overseas market because of global economic uncertainties such as the COVID-19 pandemic's evolution, new administration of the U.S., aftermath of Brexit, and etc.

- The Japanese investment to Korea went down 49.1 percent to \$730 million while that the arrived significantly decreased 57.9 percent to \$500 million.
- FDI pledged from the EU to Korea contracted 33.8 percent to \$4.7 billion, and those arrived dipped 47.0 percent to \$3.8 billion.
- China's investment in Korea moved up both in notification and arrival basis, 102.8 percent and 16.1 percent respectively.
